

Round & Little Round 2013 Aquatic Plant Management (APM) Chemical Treatment Plan (as of 6/21/13)

August 2012 Round & Little Round Surveys completed by Tom Connell Individual Commercial Pesticide Applicator #282828-CA & Kristy Maki Sawyer County Aquatic Invasive Species (AIS) Coordinator. Surveys on www.roundthelake.com These surveys used to complete WDNR 2013 chemical permit applications on Round & Little Round Lakes. 6/4/13: Round & Little Round APM treatment plan approved by WDNR. 22 acres on Round & 3 acres on Little Round.
Round Lake Permit # NO-2013-58-816
Little Round Permit # NO-2013-58-817

6/19/13: DNR Approved Chemical permits physically received by RLPOA.

6/26/13: Tentatively plan **pretreatment survey** on Round & Little Round Lake by Tom Connell & Kristy Maki.

Chemical treatment specifics will follow based on professional judgment of Tom Connell Individual Wisconsin licensed Commercial Pesticide Applicator & Kristy Maki AIS Coordinator for Sawyer County. Full compliance with WDNR guidelines and approved permits will be followed. The chemical treatment date will be picked by Mr. Connell in consultation with Kristy Maki as needed complying with WDNR guidelines. The areas treated will be determined by pretreatment survey but not larger then what was permitted by WDNR.

Chemicals used and approved by WDNR: DMA 4 and Navigate. Max G (used last year) was not approved. Method of application will be “granular spread and sub-surface injection”. As of today the actual permits are not consistent with each other concerning chemicals and a clarification email is available from Mark Sundeen of WDNR on 2013 milfoil chemical treatment summary page noted above.

According to Tom Connell the WDNR has requested to be involved with monitoring Round & Little Round treatment this year. The WDNR reportedly wants to be physically present during some of the chemical treatment. RLPOA welcomes this.

Post treatment surveys will be done when appropriate usually the first comprehensive one within 30 days. Surveys will be done by Kristy Maki &/or Tom Connell.

WDNR Chemical Treatment Permits this year are valid thru **10/1/13** on both Round & Little Round. Spot retreatments are planned as needed. This will be followed up with additional surveys and there will be one final late summer AIS survey.

07/01/13: DNR required “treatment” notices distributed to riparian owners.

Large scale permit approved on Round Lake so treatments can be done over 10 acres for 5 years.
